

National Training on Digital Government and Transformation

6-8 September 2023, Yerevan

BACKGROUND

The Asian and Pacific Training Centre for ICT for Development (APCICT/ESCAP) was established in June 2006 as a regional institute of the Economic and Social Commission for Asia and the Pacific (ESCAP) in Incheon, Republic of Korea. The Centre's mandate is to build the human and institutional capacity of the 62 ESCAP members and associate member States to use digital technologies for sustainable development.

Since its inception, APCICT/ESCAP has been providing impactful capacity building programmes on digital development to support members States on their digital transformation and to bridge the digital divide in the region. Through its flagship programme, the Academy of ICT Essentials for Government Leaders (Academy), the Centre strengthens capacities of policymakers and civil servants on ICT policymaking and integrating digital technologies in national development strategies and programmes. Since its launch in 2008, the Academy has seen a wide uptake and institutionalization across the region and has been rolled-out in 40 countries.

The Academy's rapid uptake and success are attributed to the unwavering support and dedication of APCICT's vast network of partners throughout the region. To strengthen the on-going collaboration, APCICT/ESCAP, in partnership with the Public Administration Academy of the Republic of Armenia (PAARA), is organizing a **National Training Programme on Digital Government and Transformation for Armenia** on 6-8 September 2023. The event is targeted at managers and mid-level professionals from central and local governments as well as government officials responsible for the development and implementation of digital initiatives in the country.



In recent years, Armenia has made significant efforts to advance its digital infrastructure and promote the development of digital solutions and services. Digital transformation and inclusive digital development are key priorities for Armenia as it seeks to leverage the power of digital technologies to drive economic growth and build a more inclusive and sustainable society. By prioritizing inclusive digital development, the government can create accessible and citizen-centric services, ensuring that all members of society can access essential government services and participate in the digital economy.

The training will provide an overview of how digital technologies can be used to improve the quality of governance and public administration. It will highlight and build on the key principles considered useful for digital government strategy and policy. At the same time, the training will emphasize the importance of inclusive digital development in policymaking. As social media can be used to drive digital transformation initiatives in various ways, the training will discuss the role of social media in the digital transformation of the public sector.

OBJECTIVES

By the end of the training, participants will:

- Have greater appreciation of the growing pervasiveness of digital technologies in our public and private spheres and how the adoption of these technologies can impact governance;
- Understand the causes of failures of digital government projects; explore the use
 of design thinking in public service delivery; and discuss collaborative and
 participatory tools and methods to encourage both citizens and civil servants to
 participate in the design of digital government services;
- Explain components of Digital Government strategies and plans, and the associated processes; expand on the regulations and legal framework required for effective digital government transformation; and
- Understand the different phases involved in implementing a digital government project life cycle; explore the emerging trends in digital government program implementation.
- Understand the concept of inclusive digital development and its importance in policymaking.



• Understand the role of social media in governance and its implication for national policy and program formulation.
