■ Jun. 8:

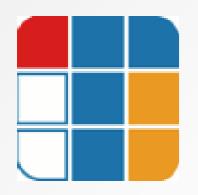

IMPACT

In June 2013 an official GCIO program was launched and the plan for establishing the E-Governance Center was announced. All ICTD activities are currently reviewed and coordinated by the E-Governance Center. The Center plans to formulate new strategy to drive ICTD programs and projects.

The local UNDP office is our main partner. It supported the establishment and the institutional capacity building of the E-Governance Center and the development of the GCIO program in Kyrgyzstan.

In the upcoming years, the National Information Technology Center will work to further develop the GCIO program.

- ■The importance of having a one-stop unit at government to formulate policies and strategies to drive ICTD programs and projects.
- The role and importance of regional cooperation, especially in academia CAREN and KRENA.
- The importance of networking among interested parties.
- The necessity of affordable Internet provision.
- The necessity of more funding opportunities to start regional projects.
- The necessity to develop an educational and examination web portal for the GCIO program and to integrate it with the Government's HR information management system.
